One Set of Numbers - Not Two

Virginia's General Assembly and local governing bodies will redraw election districts based on the official 2000 Census redistricting counts—one set of numbers based on the actual population counts.

On March 1, a special committee of the Census Bureau recommended that one set of Census numbers—the actual counts—be released as the official numbers for redistricting. The committee concluded that the Bureau's efforts to improve the actual counts by statistical adjustments had not yet proved successful. The Secretary of Commerce confirmed the committee's findings on March 6 and authorized the release of one set redistricting population numbers based on the actual counts.

Redistricting Data for Virginia

The Census Bureau sent Virginia officials the redistricting population numbers on March 7 and posted the numbers on its website on March 8. The three tables that follow show the total population for Virginia's current House of Delegates, Senate, and Congressional districts. There is a wide variance in populations from the ideal district populations of 70,785 (House), 176,963 (Senate), and 643,501 (Congressional). The plus to minus deviation range for the House is +78.7% to -36.2%; for the Senate, +48.5% to -22.8%; and for Congress, +18.8% to -13.4%. Courts have accepted a +5% to -5% deviation for state legislative districts, but little or no deviation for Congressional districts.
