As the City isn't populated enough for a stand-alone House Seat, I recognize the need to include small portions of the surrounding area to balance the seat. Having lived in the City for some time, I have seen the development of the south and western areas of town, with spill over particularly in the Forest area. Thus, I am further in agreement with the arrangements of the consultants, while there are some very, very small deviations (which I am sure can be addressed promptly and easily).

Also, I believe the Forest area that is included in both situations is fairly compact by itself and is the best scenario to include with the City as it doesn't cross any natural or transportation boundaries, or split any other communities of interest.

As far as the Senate seat, again, my appreciation for keeping the City together. My only thought is I'm not sure what Lynchburg has in common with the Rockbridge area, though I recognize the need for population boundaries. This comment applies to both the A3 and B3 House of Delegate District proposed maps. I attempted to add my comment to the website map portal but the form froze in the "processing" position so I am unsure if my submission went through.

I was honored that Craig County was the #1 voting locality (81.7%) for the formation of the Redistricting Commission. In part, this was because Craig County is currently represented in the Virginia Senate by a Senator in Lynchburg. Though Senator Newman has done a fine job of representing our values, it is easy to see that Craig County is culturally and geographically different from Lynchburg and interested in different priorities. It is my assessment that Craig County should be in a Roanoke-based House of Delegates district to maintain our community of interest. I was disappointed to see that Craig County has been drawn into a district weighted overwhelmingly in Montgomery. Though Craig County shares a small border and a backroad with Montgomery, we do not share much else.

Craig County is in the Roanoke Metropolitan Region with a Roanoke-centric population base. A vast majority of our workforce travels to Roanoke County every day for employment utilizing Craig County's primary road, Rt 311, for travel. Rt. 311 is also a road maintained out of the Roanoke-based VDOT Salem residency. Craig County has just one small grocery store and most households rely on Salem/Roanoke as the closest source of broader options and prices. The largest industry in Craig County, a sand mining plant, relies on roads in the Catawba Valley to reach the Roanoke Cement Co. If you dial 911 in Craig County and need transportation to a hospital, the odds are more than 85% in favor of you being transported to a Roanoke-based hospital. Craig County law enforcement is trained at Cardinal Justice Academy in Salem and our allotment of State Troopers serves out of the Area 40 Office (Roanoke and Craig Counties).

Our namesake, Robert Craig, was a Roanoke-based delegate. To remove Craig County from a Roanoke-based district would ignore substantial precedent in the fact that Craig County has never been paired within a district which does not include Roanoke County or Botetourt.

Removing Craig County's Roanoke-based representation in the House of Delegates serves only to detach our interests from representation in Richmond. Craig County should be in a Roanoke-based House of Delegates district and not a district 94.2% (A3) (95.8% B3) weighted in the New River Valley.

The nested DD delegate districts in each congressional district CD can be apportioned in a nearly 'nested' fashion into SD senate districts.

In ten (10) apportioning steps allocating previously nested DD delegate districts within each congressional district CD, two-and-a-half (2.5) DDs can be drawn for each SD senate district (with the only exception the first small CD with ten small DDs which is insufficient to populate four small SDs alone).

Recall from the previous post: an average congressional district = 9 average DDs + 1 average DD = 10 DDs (=2.5 + 2.5 + 2.5 + 2.5 DDs) = 4 average SDs

Assume A:

The 1st

-drawn CD in Northern Virginia should have a small population (average-2%=760,480 ) uniquely with 10 smallest DDs (ave.-2%=76,048). When one average DD is apportioned from the 2

I am asking commission members, regardless of party affiliation, to reject political considerations in designing district boundaries. Please utilize planning district boundaries and exclude addresses of General Assembly members in the mapping criteria. The criteria for voting districts should include compactness, contiguity, racial equity, and representation by communities of interest. Past gerrymandering has unfortunate results, for example my area is split into four Senate districts: two including western neighbors in the Shenandoah Valley, and one from Spotsylvania in the East, and Lynchburg to the south. Likewise, our area is split among five House districts, including two from the Valley and Richmond. Our Congressional District stretches from Fauquier to the North Carolina border. Across the state other glaring examples abound where the communities of interest are split up and not truly represented by a common legislator. The 23 existing Planning Districts, which are created by Virginia statute, could be used as the basis for drawing legislative and congressional districts. The counties and cities in these PDs are contiguous, share a common geography, and have collaborated on common interests, such as housing, transportation, economic development, and waste management. Because the Planning Districts are creations of the state government, using their structure as a template for redistricting is most appropriate. Congressional districts could be fashioned by combining some portions of adjacent PDs. To reach the ideal size for congressional districts, some PDs would need to be combined in whole or in part with adjacent PDs

My name is Niro Rasanayagam and I made the following comments at the virtual public hearing last night. I am concerned that not all the Commissioners are required to attend all the public hearings, and would like to share my comments via email here for their benefit.  
I have lived and paid taxes in Lynchburg for 18 years. The City of Lynchburg is a small urban city. Lynchburg’s social, cultural and economic interests are DIFFERENT from those of the more rural counties –to whom we have unnaturally been attached to since 2011. The rural counties currently dominate the portfolios of most of our legislators, diluting Lynchburg’s community clout and diminishing our voice in Richmond.  
In terms of taxes, infrastructure, economic development, the public school system, environmental and planning pressures, and public safety, the City of Lynchburg’s needs and interests are best advocated by a single House Delegate and a single State senator for whom Lynchburg voters are the bulk of their constituents.  
For example, Lynchburg has a significantly higher poverty rate, in some cases almost double the poverty rate, than our nearby rural counties. Our schools, transportation systems, medical care systems, and housing solutions must work for and serve this higher-needs population. We need legislators who understand our urban strengths and challenges, and who will respond to and advocate for our urban interests.  
The current “cracking” of Lynchburg into four districts, instead of two, is also confusing to voters and is impractical. Currently, many precincts even within the same election wards in Lynchburg are in different districts! This makes no sense and it also makes it more expensive for the City Registrar to administer and run elections.  
The basic tenet of the Code of Virginia 24.2-305 which states “each election district and precinct shall be composed of compact and contiguous territory and shall have clearly defined and clearly observable boundaries” was not followed for Lynchburg during the 2011 redistricting process after the 2010 census. I urge you now to please rectify that and restore Lynchburg as a single community of interest. Neighbors across the street, or a few doors down, could be in entirely different House and Senate districts! Even the savviest voters have a hard time keeping track of who their representatives are and what district they’re in—because it could be any two of a four-way combination! The only way to know for sure is if a constituent takes the time to put in their address and looks it up online! And even then they will need to know where to look and how to do this. This adds to voter confusion, frustration, and disengagement from the democratic process.  
I want to stand with my fellow residents from all over Lynchburg on issues that impact us City residents, and right now I’m feeling a little powerless. For example, I care about downtown revitalization, but I have no say there with my Delegate because my Delegate does not cover downtown Lynchburg.

Instead of putting us with fellow Lynchburg residents in a single Senate district, we are lumped in with residents of Craig County, bordering West Virginia on one end, and with residents of tiny Goochland County almost near Richmond on the other end.

No offense to them, but I didn't even know where these far-flung counties are located (Craig, Goochland, Buckingham, Louisa, Cumberland, Fluvanna). I've had to go look them up on a map of Virginia. I have no affinity with these distant rural counties. It makes no sense to me that I've been lumped in with them rather than with my friends and neighbors right here in Lynchburg.

Please restore the City of Lynchburg into the single community of interest that we naturally are, with a single HOD and a single Senate district. Thank you for your service to Virginia and please be objective when drawing these maps!

Hello Selection Committee members,

Thank you in advance for your service to advance a fair and effective redistricting process. You have an incredibly important job (as I'm sure you know!) and the citizens of Virginia are counting on you to represent competing and often contradictory interests. I wish you the best in this challenging but worthy endeavor.

It was natural to see that the legislator "short list" of 64 citizens included primarily Republican citizens from rural areas and Democratic candidates from the urban areas -- since that is how our General Assembly is primarily constituted. However, I would like to suggest that you select at least one of Democratic citizen member of the commission from outside of the urban crescent area.

Why? We have significant Democratic presences in rural Virginia municipalities that should not be overlooked. Our numbers are often obscured by the existing gerrymandering that has split places like Lynchburg into two House of Delegate districts and two State Senate districts (all VERY safely Republican). However, voting within Lynchburg City limits is often very close to 50-50, and indeed went Democratic in the 2019 Presidential election, with 5-2 Democratic representation on the City Council. The message: rural Democrats exist and we should have a voice in the redistricting process.

I'm sure the reverse holds true as well, with Republican contingents in urban areas, and so I encourage you to look broadly at how to ensure a balanced representation across the entire Commonwealth.

First, I want to offer my thanks to each of you for your service to Virginia. You are doing hard, important work, and I'm grateful to you for your leadership, skill, and care as you weigh the many considerations before you.

I write as a Lynchburg native and current at-large member, as well as vice-mayor, of Lynchburg City Council, and urge you to unify Lynchburg into single legislative districts. As you may be aware, until 2011, Lynchburg was wholly encapsulated within the 23rd House of Delegates District and 23rd State Senate District.

That districting arrangement made sense, given that Lynchburg is, as it was then, a single community of interest: a geographically distinct city with a rich history and cultural legacy, a single city council, single school division, single police and fire departments, etc. After 2011, however, our city was split, between two House districts and two Senate districts. Because we are not a unified whole, these lines have had the unfortunate effect of diluting Lynchburg's influence in Richmond. It's also costly — our registrar, for example, has to print up to four ballots for state elections — and is terribly confusing for voters, many of whom live across the street from someone in a different House or Senate district, or both.

Surely, Lynchburg voters have more interests in common with each other than Virginians living not just counties away, but in the case of the 22nd Senate District, nearly 100 miles away.

With approximately 83,000 people of innumerable common interests, Lynchburg deserves to be unified into single House and Senate districts.

Currently, after the 2010 redistricting, Lynchburg was artificially “cracked” and carved into four artificial districts--two House districts and two Senate districts—which has not worked to Lynchburg’s favor in policy terms. Each of the current four districts unnaturally attaches the City of Lynchburg artificially into counties that are far more rural in nature that surround us. The New River Valley should stay as one entity if at all possible. The counties and city have worked hard to become a cohesive group of entities for the outside world. The NRV includes Floyd, Giles, Montgomery, and Pulaski counties and Radford City.

Montgomery County and the New River Valley have stronger ties with Roanoke and the

Other comments:

Proponents of splitting Montgomery County, let alone the New River Valley talk about "the number of representatives that we have in Richmond." That representation hasn't "brought the bacon" back to this area. It allows our representative to pick the low hanging fruit outside of Montgomery County, and not deal with the difficult issues in one of the biggest economic engines in southwest Virginia (second to Roanoke).

The biggest addition to our economy is the fact that Amtrak will be expanding to Montgomery County. This is only after the expansion to Roanoke that has been more successful than expected (the New River Valley riders are a substantial portion of the ridership).

Virginia Tech, Radford University, and New River Community College receive substantial funding from Richmond, but that would happen anyway despite Montgomery County and the New River Valley being split among elected state level districts.

I would like to urge you to include the city of Roanoke in the 9th District. Roanoke is the heart of southwest Virginia. Even its airport is named Roanoke-Blacksburg. The rest of Virginia identifies with Roanoke as a gateway to southwest Virginia. Roanoke County and Roanoke are surrounded by mountains so they seem to be the essence of southwest Virginia mountains.

Also, I urge you to draw districts that are contiguous. That is, the districts should include a whole county if possible rather than dividing up one county into too many Virginia delegate or senate districts. For instance, the 12th district House of Delegates included all of Giles County which was a good thing. But, the district only included part of Blacksburg, some precincts in Radford, Fairlawn, and Pulaski District. A more equitable 12th would include all of Blacksburg and then Giles County.

My reason for advocating for contiguous districts is so that constituents in each district should feel a community connection with each other. This connection is stronger if the district is defined by its community and not by arbitrary lines.

Some other recommendations:

1. If a district is too wildly configured into lines that go here and way over there or resemble wildly shaped creatures, you can conclude it does not define a community. So, please reject these type of districts.
2. The closer a district resembles simple shapes like ovals, circles, squares, or rectangles the better that district will be in representing a community.
3. A district should have some landmark or defining area that is at the core of a district. For instance, it makes sense that Virginia Tech would be the core of the 12th District House of Delegates with surrounding areas included (such as Giles County where so many VT employees live). It makes sense that Roanoke would be the landmark for the 9th U.S. Congressional District with the other landmark being Abington on the southwest Virginia border.

So my emphasis is on creating communities with districts. Thank you for your attention to these recommendations.

On the local level, we've consistently elected diverse, progressive officials--including our delegate, Sam Rasoul, the only Muslim immigrant in the state legislature. Ditto with the city council, the mayor, and sheriff. We're happily led by a mix of women, BIPOC, and LGBTQ individuals. However, on the federal level, our congressional district has always been rolled into (and diluted with) a much more conservative and white population because the 6th district strangely includes the I-81 corridor north past the Harrisonburg area--yet doesn't include Charlottesville. And the result is that we've been consistently represented on the national level by conservative Republicans like Bob Goodlatte.

Roanoke has much more in common with Charlottesville and the New River Valley in terms of culture, population, education, and industry. Plus we have educational and financial ties with the NRV through the medical and nursing schools in Roanoke. The former is a joint-venture with Virginia Tech while the latter is with Radford University, both of which are located in the NRV. Over the past 20 years, Roanoke has moved away from being a railroad town to a hip, diverse, outdoor-oriented medical hub--and we deserve a congressional district that values the same things and has similar interests.

Thank you again for the opportunity to address the Commission during the virtual public hearing on July 15. My comments were:  
My name is Bill Bestpitch, and I serve as a member of Roanoke City Council. Following the 2008 and 2012 presidential elections, City Council heard from numerous voters who waited for extended periods of time to cast their votes. Some said that they were not able to wait due to job or family requirements, so they were not able to vote at all.  
At that time, Roanoke had 32 precincts, some with fewer than 1,000 voters and some with approximately 3,500 voters. The larger precincts were the ones that experienced the greatest delays in voting, and most of them were majority African American precincts.  
Working with the Electoral Board and our General Registrar, we revised our precinct lines so that we now have 20 precincts, with an average of approximately 2,500 voters in each precinct. We have not experienced any significant wait times for voters since the new precinct lines went into effect.  
All our elections for mayor, city council members, and Constitutional Officers are conducted at large. All of the City is in the 21st District of the Virginia Senate and the 6th Congressional district. Eight precincts are split between the 11th and 17th House of Delegates districts. We respectfully request that the Commission simply follow our precinct lines when drawing districts for the General Assembly and Congress.
